OPERATOR COMMENTS AND SUBMITTAL

Comments

Please see the summary below detailing our plans to sidetrack the lateral section of the Critter Creek 16-5906D (API 05-123-47307). Please let us know if you need any additional information.

- Following reaching total depth in the wellbore at 18119'MD we tripped out of the hole to lay down directional equipment and proceeded to trip back in the hole with a conditioning assembly. With this assembly we reached a depth 17590'MD. The drill string took weight and required extremely high torque as we attempted to clean up the wellbore. After several hours the assembly was tripped out of the hole at which time it was discovered that 38 stands of drill pipe had been left in the hole. Top of the fish is at 13942'MD. Two subsequent fishing attempts were made confirming top of fish but these trips proved unsuccessful. We are requesting approval to sidetrack away from the affected lateral section.
- Fish in hole is from 13942'MD to 17590'MD and consists of drill pipe and a bit.
- The total MD of the hole to be abandoned is 18119'MD
- The 9-5/8" surface casing string is set and cemented at 1544' MD
- The 7" intermediate casing string is set and cemented at 8116' MD
- The Sidetrack KOP is estimated at 12200' MD
- The objective formation for the lateral sidetrack hole is the Codell formation, which is the same objective formation as the lateral section being abandoned.
- The PBHL of the sidetrack hole is the same as the wellbore being abandoned.
- There are no proposed cement plugs.

This well has a bottom-hole location beyond the unit boundary setback. The bottom of the completed interval will be within the unit boundary setback at 300' FNL and 1925' FEL of Section 9. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.

The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log.
