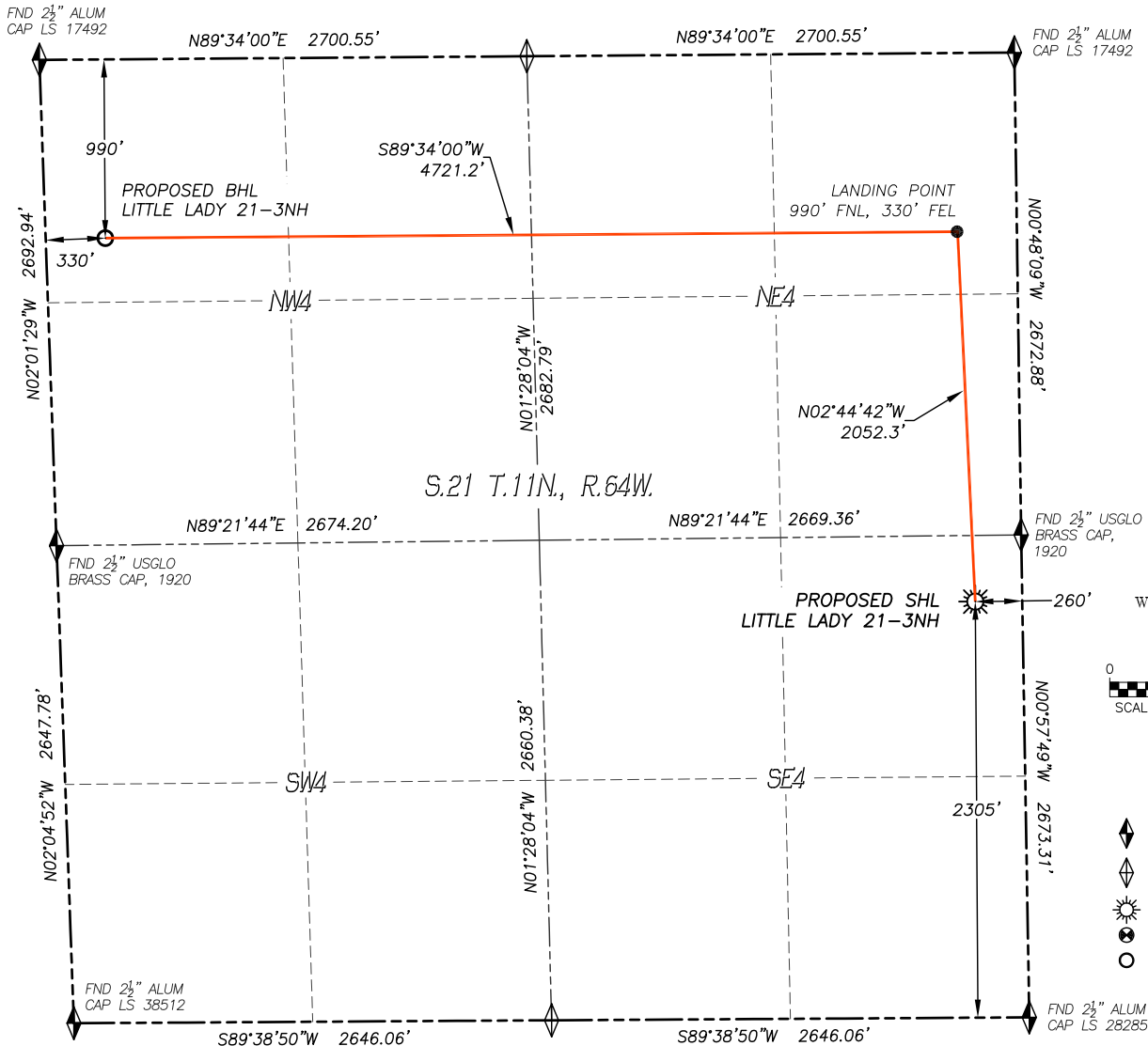


WELL LOCATION CERTIFICATE

SECTION 21, TOWNSHIP 11 NORTH, RANGE 64 WEST OF THE 6TH P.M.

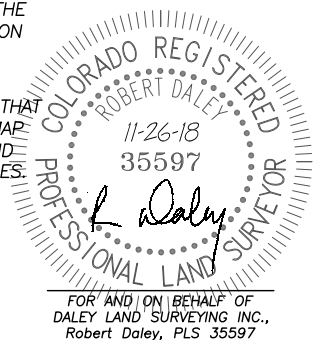

HAS DETERMINED THE SURFACE LOCATION OF THE LITTLE LADY 21-3NH WELL TO BE 990' FNL, 330' FEL, AS MEASURED AT NINETY (90) DEGREES FROM THE SECTION LINES OF SECTION 21, TOWNSHIP 11 NORTH, RANGE 64 WEST, OF THE 6TH PRINCIPAL MERIDIAN, WELD COUNTY, COLORADO.
