


# WELL LOCATION CERTIFICATE

SECTION 21, TOWNSHIP 11 NORTH, RANGE 64 WEST OF THE 6TH P.M.




IN ACCORDANCE WITH A REQUEST FROM UPLAND EXPLORATION INC., DALEY LAND SURVEYING, INC. HAS DETERMINED THE SURFACE LOCATION OF THE LITTLE LADY 21-5NH WELL TO BE 1650' FNL, 330' FWL, AS MEASURED AT NINETY (90) DEGREES FROM THE SECTION LINES OF SECTION 21, TOWNSHIP 11 NORTH, RANGE 64 WEST, OF THE 6TH PRINCIPAL MERIDIAN, WELD COUNTY, COLORADO.

I HEREBY STATE THAT THIS WELL LOCATION CERTIFICATE WAS PREPARED BY ME OR UNDER MY DIRECT SUPERVISION, THAT THE WORK WAS COMPLETED ON 11/13/2018 FOR AND ON BEHALF OF UPLAND EXPLORATION INC., AND THAT THIS MAP DOES NOT REPRESENT A BOUNDARY SURVEY, IT IS NOT A LAND SURVEY PLAT OR AN IMPROVEMENT SURVEY PLAT AND IT IS NOT TO BE RELIED UPON FOR THE ESTABLISHMENT OF FENCE, BUILDING OR OTHER FUTURE IMPROVEMENT LINES.
