Comments

Nearest well to the proposed wellbore completed in the same formation: GP Alles FED 17W-25-2N, operated by Extraction Oil and Gas, Inc. Nearest well belonging to another operator: Commerce Center 4 Federal 20-2HS, API 05-123-18755, operated by SRC Energy. Interwell distances were determined using our in-house 3D anti-collision reports.

Surface location remains the same with a new landing point and bottom hole location. Updated drilling plans and plat are attached. The Surface Use Agreement for this location was signed July 26, 2013 and this location is within a Buffer Zone - document already on-file with COGCC. Extraction Oil & Gas respectfully requests the Director grant an exception as per Rule 604.b.(1)A. & Rule 604.b.(2) - document already on-file with COGCC. Extraction Oil & Gas requests an exception to Rule 318A.a. since location is not within a GWA window. The surface owner waives this Rule in the SUA (highlighted on p.4).
