OPERATOR COMMENTS AND SUBMITTAL

Comments

Extraction respectfully requests to refile the existing APD with the following changes: new name, LP, BHL, deviated drilling and casing plans.

Nearest well to the proposed wellbore completed in the same formation: GP-HILLSIDE FED 20W-20-13N, operated by Extraction Oil and Gas. Nearest well belonging to another operator: Segl 2-24, API 05-123-23841, operated by SRC Energy Inc. Interwell distances were determined using our in-house 3D anti-collision reports.

Surface location remains the same with a new landing point and bottom hole location. Updated drilling plans and plat are attached. The Surface Use Agreement for this location was signed July 26, 2013 and this location is within a Buffer Zone – document on-file at COGCC. Extraction Oil & Gas respectfully requests the Director grant an exception as per Rule 604.b.(1)A. & Rule 604.b.(2) – document on-file at COGCC. Extraction Oil & Gas requests an exception to Rule 318A.a. since location is not within a GWA window. The surface owner waives this Rule in the SUA (highlighted on p.4).
