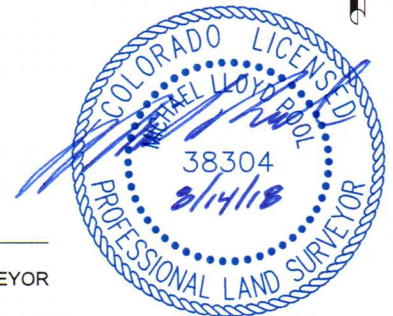

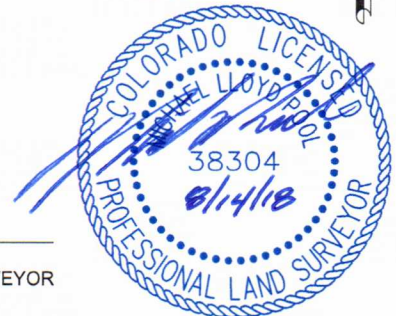
FRYE NORTH 29E-20-10C WELL LOCATION EXHIBIT
