Comment The northeastern and eastern berm has little desirable vegetation and is largely bare soil. Scattered musk thistles observed throughout the project area, and approximately 150 Russian knapweed in the northwestern project area.

Corrective Action The northeastern and eastern project area needs revegetation. This should be conducted during the spring 2019 seeding window and no later than May 1, 2019. Weeds need to be controlled at the appropriate time but no later than June 1, 2019.
