Comment: [Location does not yet meet Reclamation Regulations. Desirable vegetation establishment is not uniform across site; there are areas bare of vegetation, and areas infested with weeds \(Russian thistle, cheat grass, Redstem fillaree\). It appears that Stormwater flow, pooling and sediment migration onto site, have contributed to the failure to revegetate as addressed in previous Inspections. There is also some evidence of vehicle traffic into Location. Refer to Stormwater section & Photo Log attached.](#)

Corrective Action:	Assess vegetation & site conditions. Apply remedies /conduct reclamation activities needed, as indicated by assessment, to ensure the uniform establishment across the site of desirable vegetation.
