**Comments:**

The Wagner 1-21 was spudded December 26, 2000. It was thereafter determined to be a dry well, was plugged and abandoned on December 29, 2000. As of April 5, 2018, the well site is and has been native grass pasture land used for grazing livestock. While the location was fenced off to prevent livestock from affecting the reclaimed area, the surface owner has requested that the fence be left in place for the surface owner's use. No additional reclamation work is required at this location. Despite several attempts the surface owner has not executed a surface use agreement.
