General Comment:

Joint field visit between COGCC, BLM, and operator in response to Spill/Release ID #459154. Work to delineate and remediate impacts associated with the subject spill is proceeding under approved Remediation Project #12168.

The subject spill resulted from a leak of an estimated 46 bbls into an unlined, metal SPCC from a production tank. On inspection date, production tanks had been removed, SPCC was partially disassembled, and flowline risers inside of tank battery had been exposed via hydroexcavation. Operator discussed spill/release discovery, sampling for delineation, and remediation options with surface owner (BLM) present.

Two temporary tanks have been brought to location to be used until the remediation is complete and new tanks can be installed. Operator has submitted a Form 04 Sundry Notice (doc #401856603) to document the presence of the temporary tanks on location.
