Corrective Action: Perform reclamation in accordance to COGCC 1004 reclamation rules and requirements. Reseed disturbance areas. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Clean out cattle guard. Manage noxious weeds by 6/25/2018 due to that flowers will develop shortly. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards. Final reclamation activities shall be complete no later than 9/17/2018 or sooner depending on favorable environmental conditions.

Operator Comment: Weeds were taken care of on 6/21 and the cattle guard has been cleaned out. Kerr McGee will mow and continue weed control on this site. However, due to the current active remediation project taking place at this location, and active midstream gathering equipment, additional reclamation processes will be postponed until the remediation is complete and midstream equipment is removed.

COGCC Decision: Approved pending re-inspection

COGCC Representative: Based on correspondence from the previous inspection, access is needed for midstream gathering equipment located east, adjacent to the location. When the midstream gathering equipment is no longer needed, Operator shall comply with Rule 1004 to reclaim the access road and any other disturbances, including the remediation project.

Final reclamation activities were conducted previously but failed because of remediation activities per a conversation with the Operator on 11/7/18. Operator has not performed additional final reclamation activities since the previous inspection. Operator shall continue to monitor and manage the Location for erosion and weed control until the location meets Rule 1004 standards.

Comment: Weeds were taken care of on 6/21 and the cattle guard has been cleaned out. Kerr McGee will mow and continue weed control on this site.
