General Comment:

COGCC environmental joint inspection with COGCC Western Integrity Inspector. Follow-up to Spill/Release Report (doc #401870624) corresponding to Spill/Release ID #459792.

Operator was onsite testing the repaired flowline for integrity on inspection date. Open excavation, adjacent to wellhead, measured approximately 6'x10'x4'. Additional, unidentified 2" flowline was exposed on east side of excavation. Operator was instructed to cap unidentified flowline by Integrity Inspector.

Three monitoring wells (capped, 2" PVC risers) observed south of excavation. See photos.

Environmental**Spill/Remediation:**

Comment: [Spill/Release ID #459792](#): Operator indicated that confirmation samples had been collected from the excavation by an environmental consultant and that the excavation would be partially backfilled with clean soil to prevent flowlines from freezing overnight. Impacted soil had been stockpiled on east and west sides of excavation. Operator indicated that soil would be hauled off for disposal.
