Comment:

Portion of the Pad & access road have not been reclaimed & were part of agreement between Surface Owner & Garfield County to utilize as staging area in 2014. It appears that site had reclamation installed by 2011, except for the access road, before, the 2014 agreement. Why the access road was left is not apparent, as (pre O&G)existing access road for hayfields diverts from same point as Location access road. A large soil stockpile remains immediately East of the entry, and two smaller stockpiles further to the North. Reclaimed area is fenced off from County area & appears to be revegetated to hayfield grass species. Snowcover prevented detailed assessment.
