Corrective Action:	This location is not in compliance with Rule 1004 due to the presence of undesirable species and other weeds as well as observed subsidence and debris on site including deteriorated erosion control waddles and old fencing. The reclamation is not at percent cover and has non-uniform establishment of perennial cover. Well was plugged 9/1/2017. Plant species observed include but are not limited to Bromus tectorum, Kochia scoparia, Lactuca serriola, Sisymbrium altissimum, Salsola australis, Bromus Inermis, and Distichlis spicata. 	Perform reclamation in accordance to COGCC 1004 reclamation rules and requirements. Remove remaining fence, deteriorated erosion control waddles by 1/17/2019. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards.
