Corrective Action:	This location is not in compliance with Rule 1004 due to the presence of debris and noxious weeds. A List B CO Noxious weed, Scotch thistle, was observed at the location. Plant species encountered included but was not limited to Aristida purpurea, Bromus tectorum, Pascopyrum smithii, Hesperostipa comata, Sporobolus cryptandrus, Grindelia squarrosa, Artemisia frigida, Heterotheca villosa, Sphaeralcea coccinea, Gutierrezia sarothrae and Onopordum acanthium.
