3. TIH with CIBP. Set BP at 6682'. Top with 2 sxs 15.8#/gal CI G cement.

4. TIH with tubing to 5148'. RU cementing company. Mix and pump 40 sxs 15.8#/gal CI G cement down tubing (DV Tool coverage from 5148'-4648'). TOOH with tubing.

5. TIH with casing cutter. Cut 4 1/2" casing at 1800'. Pull cut casing.

6. TIH with tubing to 1915'. Mix and pump 255 sxs 15.8#/gal CI G cement w/ 2% CaCl down tubing (Pierre coverage from 1915'-1500').

7. Pickup tubing to 963'. Mix and pump 475 sxs 15.8#/gal CL G cement down tubing. Cement should circulate to surface.

8. Cut surface casing 6' below ground level and weld on cap.
