Based on observations made from the site investigation, KPK has addressed any potential impacts to soil from the partially buried vessel. Any remaining impacts to soil and groundwater is believed to be a result of a separate release from a different operator as concentration of hydrocarbon increases as the excavation gets further from all KPK equipment and flowlines. There are no flowlines connected to KPK wells or equipment that follow the contaminated soil. Additionally, there is no evidence that the partially buried vessel was ever in operation or connected to the production equipment or wells.
