From August 29, 2018 and September 25, 2018, 2,112 cubic yards of impacted soil above COGCC Table 910-1 standards was transported under manifest to Buffalo Ridge Landfill. Confirmation soil samples collected from the sidewalls and base of the excavation determined the lateral and vertical extent of impacts.
