Comment Appears the Operator has performed interim reclamation activities to reduce disturbance areas only needed for production operations. The approximate production area is 3.50 acres. Germination of desirable vegetation (smooth brome) was observed; however, germination was not uniform throughout the southern interim area. Operator may need to perform additional reclamation activities along the southern interim area.
