### DETAILS OF WORK

Well was spudded on September 30, 1960. Ran 8-5/8", 24 lb., 8 RT, J-55, R-2, STAC casing and landed at 449 feet KB. Cemented with 150 sacks Ideal bulk cement with 2% CaCl<sub>2</sub>. Cement circulated to surface. Plug down at 6:30 A.M. on October 2, 1960. Cement set for 12 hours and then was tested with 800 psi for 30 minutes and held okay.
