The well has been plugged and abandoned. The well pad (Location ID: 444427) remains in use for the producing wells (05-123-42626, 05-123-42627, 05-123-42625, 05-123-42628, 05-123-42622, 05-123-42623, 05-123-42629, 05-123-42630), which are located on the pad. The area reclaimed on the well pad has been built on, compacted, covered, paved, or otherwise stabilized in such a way as to minimize erosion to the extent practicable. Upon plugging and abandonment of the remaining producing wells on site, the entire location will be reclaimed to COGCC regulation 1004 standards. Four photographs were taken facing each cardinal direction, and one photograph was taken as a reference.
