Comment:

Operator has failed to reclaim the main access road (red dashed line in aerial and Photo 1). Historic imagery indicates this was not a pre-existing road. The last well plugged along the main access road was 8/3/2015. Wind erosion and Russian thistle, annual weed, was observed along portions of the main access road.

Operator has failed to properly reclaim the well location access road (Photos 2-4).

Well location area is not reflective of reference area vegetation. Much of the well location is bare or has sparse vegetation establishment. Operator shall do their due diligence to reclaim all associated disturbance areas per Rule 1004 (flowline areas, access road, well location). Refer to the attached inspection photos.

Corrective Action: **Comply with Rule 1004. Corrective action date is being back dated to when all final reclamation activities should have been completed and based off when the last well was plugged (8/3/2015) along the main access road.**
