The last well plugged along the main access road was 8/3/2015. Wind erosion and Russian thistle, annual weed, was observed along portions of the main access road.	Date 08/03/2016
	Well location is mostly bare with no vegetation and patches of Russian thistle which is not reflective of reference areas. Also, location appeared to have an abundance of rock.
