Well pad was undergoing interim reclamation operations on inspection date. Operator was also in the process of investigating and delineating impacted soil that had been discovered during reclamation. Approximately 3000 cubic yards of excavated, impacted soil are stockpiled inside of an earthen berm in the center of the pad. Excavation remains open on east side of pad. See photos.
