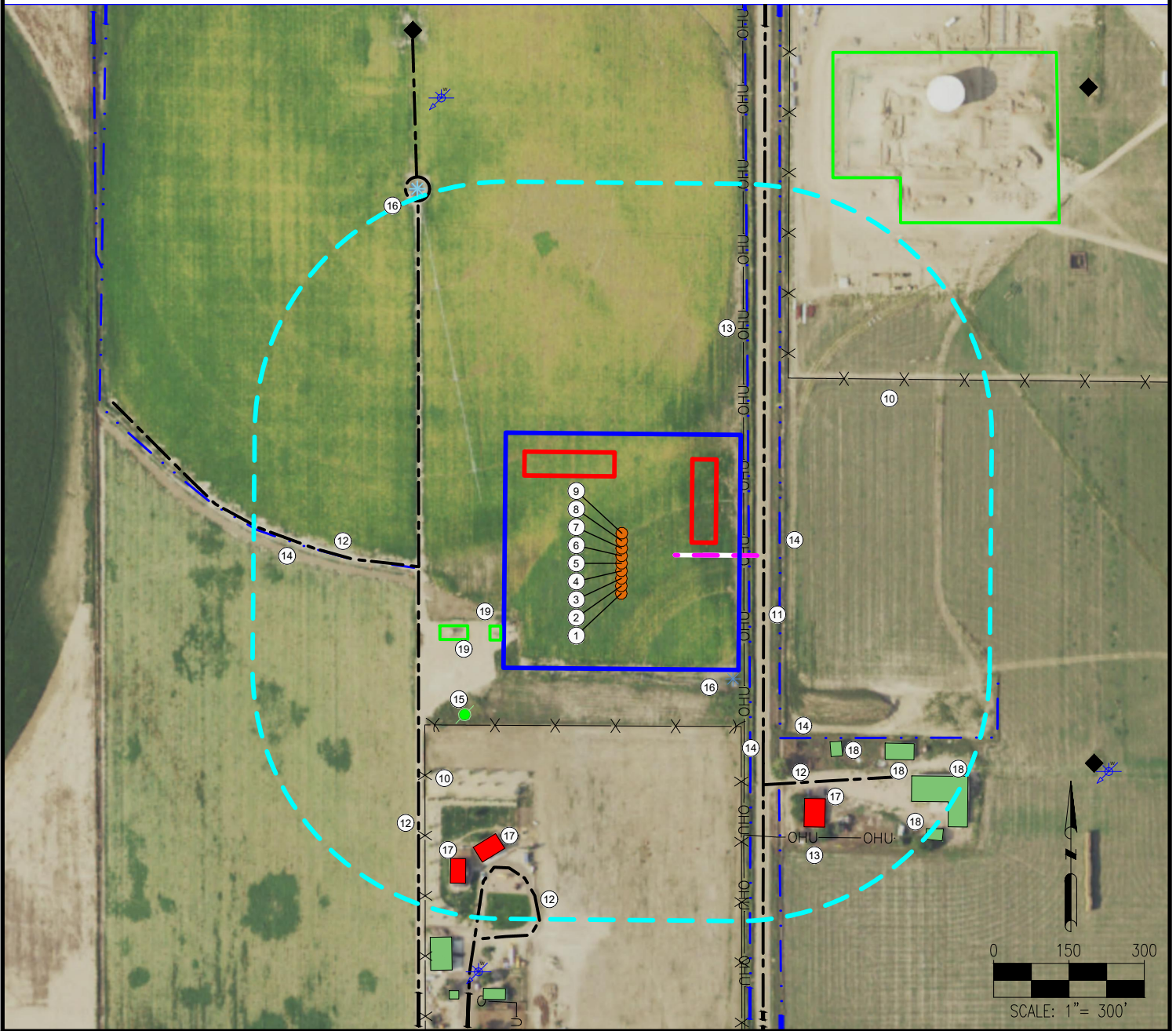


HUNGENBERG PAD LOCATION DRAWING
