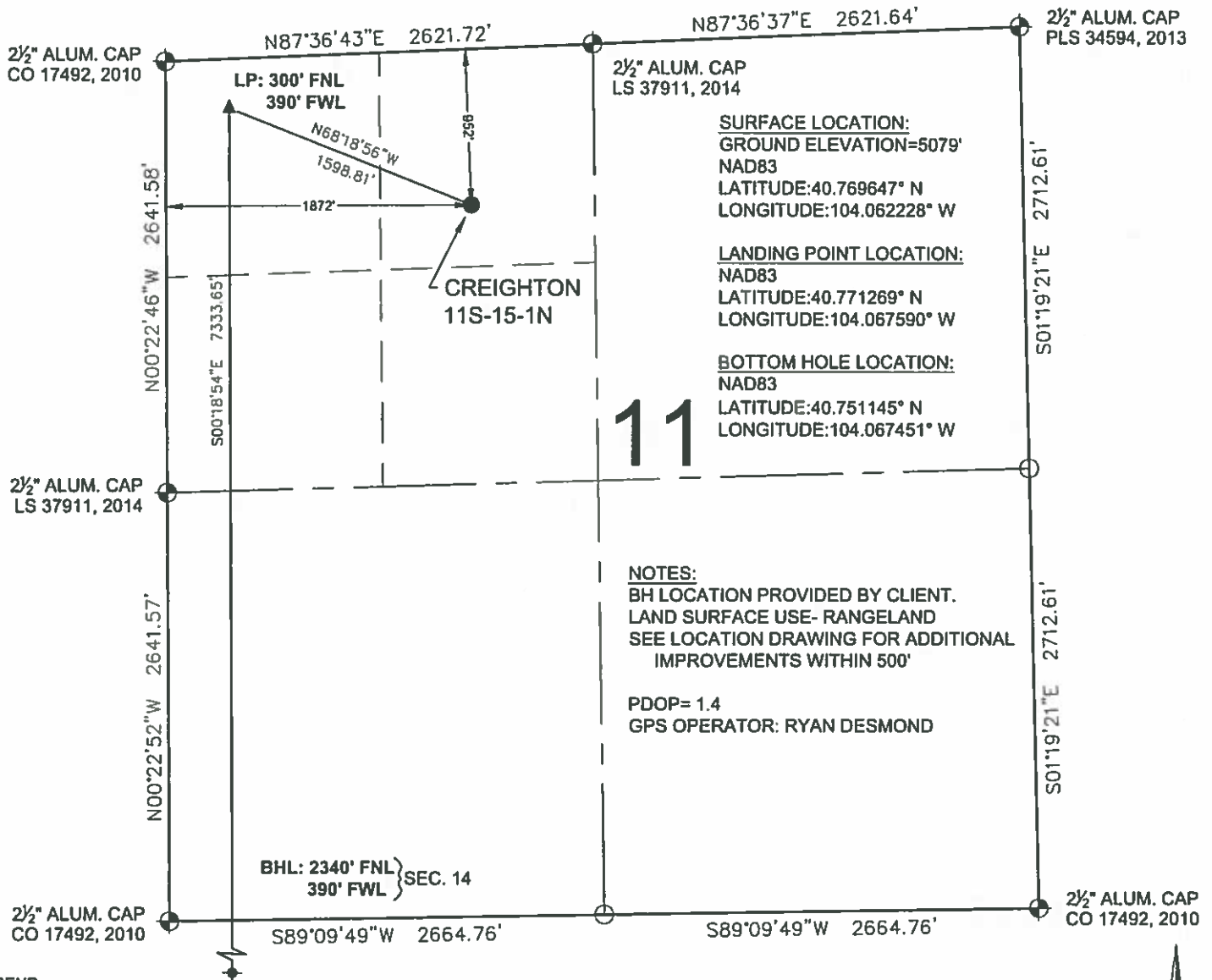


CREIGHTON 11S-15-1N WELL LOCATION EXHIBIT

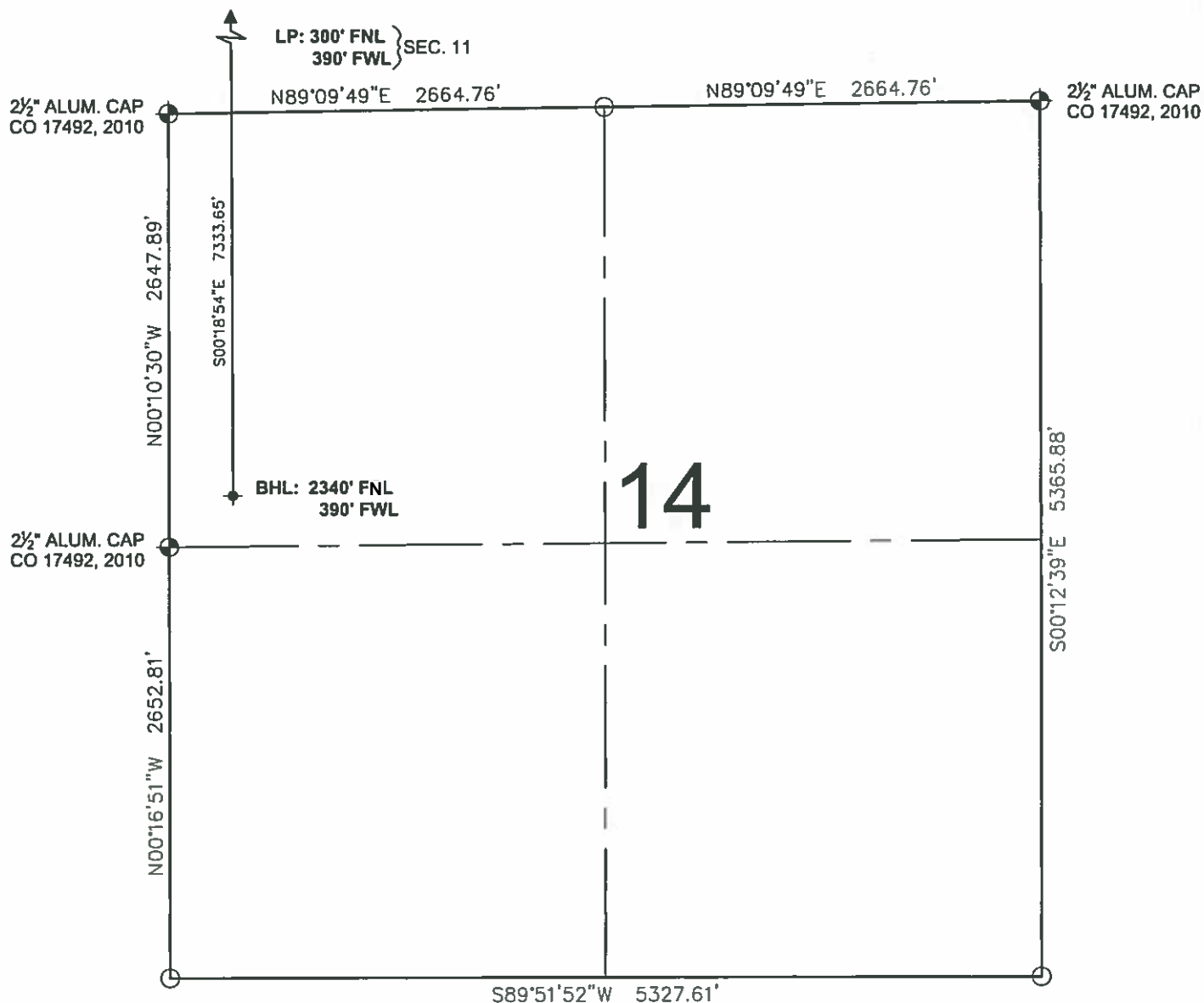
