Unable to find evidence that reclamation activities have been conducted; Access road / cattle guard remains and location remains predominantly bare and exposed soil, or predominantly undesirable weedy plant species. Corrective action and date remains applicable.

Perform reclamation in accordance to COGCC 1000 series rules and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of predisturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.
