	<p>Inspection #675103784 and 682503009 required operator to perform reclamation on access road and location, and remove pipe equipment from the location. Pipe riser equipment have not been removed and remains on the current fenced location and areas of the historic pit. Operator appears to have performed reclamation on areas of the well, however access road north to the county road have not been reclaimed. Original corrective action and corrective action date remains applicable. Due to the significant nature, extent, or duration of this alleged rule violation, location is being referred for enforcement.</p>	
Corrective Action:	<p>Perform reclamation in accordance to COGCC 1000 reclamation requirements; Remove pipe equipment and debris. Reclaim access road including, but not limited to, compaction alleviation, re-grading/re-contouring and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels on road and areas of the location not progressing. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 11/15/2017.</p>	Date <b>11/15/2017</b>
