Previous inspections required operator to submit documentation showing a rig schedule for additional drilling operations of the remaining permitted wells. Operator has failed to submit the information per the corrective action.</p> <p>Location subject to COGCC 1003 interim reclamation rules and requirements; Operator will conduct interim reclamation on areas not needed for production in accordance with COGCC Rule 1003. 1003.b requires that reclamation of the disturbed area(s) shall be reseeded in the first favorable season following rig demobilization. The first favorable season for revegetation activities has likely passed.
