Comment Inspection #682503634 and #682504182 required operator to conduct interim reclamation as the western portion of the project area does not appear to be necessary for production operations. No interim reclamation activities appear to have been conducted in accordance with 1003, and per corrective actions. Original corrective action and date remains applicable.

Corrective Action Perform reclamation in accordance to COGCC 1000 series reclamation rules and requirements; reclaim areas no longer needed for production operations and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Reclamation activities shall be complete by 11/15/2018.
