Noble Energy respectfully request continued TA status. The well is closed to the atmosphere via a RBP bridge plug set at 6,376' on 9/13/2016. The well closed to the atmosphere and locked out and tagged out at the master valve. This well was TA'd for an off-set frac, PDC's Bihain Pad. Noble will return the well to production once a rig is available - unknown time frame as we are currently working through a large back log of P&A work for offset mitigation work for DJ basin activity.
