Comment:

Germination of desirable species was observed at the tank battery and along portions of the well location access road. Kochia was observed at the tank battery and may need to be controlled. Note- There is an approved variance (Doc. #401605472) to leave the access point off CR 46 and retain the cattle guard.

Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including weed management. Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards. COGCC may conduct follow-up inspections prior to receiving said notice to ensure compliance with Rule 1004. Refer to the attached inspection photos.
