Water well permit #156288 is a stock well powered by a windmill, which was damaged in a recent snowstorm. The well owner reported that the well is inoperable.
Water well permit #70755 is a stock well. AGW attempted to reach the well owner by phone, but both phone numbers publicly available have been disconnected or are inoperable.
There are four water source exceptions requested per Rule 609.c.
The COGCC GIS Online interactive map was utilized to research the well.
