**General Comment:**

This is a Final Reclamation Inspection for PA Well API#103-40218, located within the City Limits of Rangely; on a Fee Surface/ Federal Mineral Location. This Well has Status of Abandoned Location (Not Drilled/Permit Abandoned) on Scout Card. Two Documents in files (lettering very blurred, hard to decipher) dated 2/19/1955, seem to report Production had decreased & plans were to pull rods & tubing and Temporarily Abandon Well; indicating Well was Drilled. Surface Owner (met on site) indicated position of Well that Chevron had Plugged & Abandoned shortly after they had purchased property. The Well that Chevron Plugged (API#103-05398) occupies the same approximate position as the AL Well, subject of Inspection. The two Wells may be the same Well; both are noted as Related on Chevron Location #396894. This report verifies that there is No Evidence of either Well.
