Comment: [Operator submitted sundry doc. #1786530 \(09/28/2009\) stating well has not been drilled and is abandoned. However, historic imagery and on the ground observations show location appears to have been constructed. The location disturbance area remains predominantly bare and exposed soil. Desirable vegetative establishment does not appear to be progressing. Location does not meet COGCC 1000 series reclamation standards. See attached photos.](#)

Corrective Action:	Perform reclamation in accordance with COGCC 1000 series rules and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be completed no later than 3/31/2019	Date	03/31/2019
