Noble Energy respectfully requests continued TA status. The well is closed to the atmosphere via a CIBP bridge plug set at 6,780' on 7/20/2018. The well closed to the atmosphere and locked out and tagged out at the master valve. The well was completed in the Niobrara-Codell formation. This well was TA'd for an off-set frac, Noble's Moser H22-711 Pad. Noble will return the well to production once a rig is available - unknown time frame as we are currently working through a large back log of P&A work for offset mitigation work for DJ basin activity.
