#### COMMENTS:

Noble respectfully request continued TA status. The well is closed to the atmosphere via a CIBP bridge plug set at 6840' on 4/18/2017. The well is closed to the atmosphere and locked out and tagged out at the master valve. The well was completed in the Niobrara-Codell formations. This well was TA'd for an off-set frac, Synergy's Goetzel 07-29 Pad. Noble will return the well to production once a rig is available - unknown time frame as we are currently working through a large back log of P&A work for offset mitigation work for DJ basin activity. Form 5A to change the status to TA was submitted on doc # 401304503. The initial pressure documentation was submitted on sundry doc # 401433084. Noble will run an MIT if the well is still TA'd after two years.
