COMMENTS:

Noble Energy respectfully requests continued TA status. The well is closed to the atmosphere via a CIBP bridge plug set at 6,840' on 4/18/2017. The well closed to the atmosphere and locked out and tagged out at the master valve. Well was tested at 1500 psi for 15 mins and held good. The well was completed in the Codell formation. This well was TA'd for an off-set frac, Synergy's Goetzel 07-29 Pad. Noble will return the well to production once a rig is available - unknown time frame as we are currently working through a large back log of P&A work for offset mitigation work for DJ basin activity. Initial pressure test is attached.
