This well has a bottom-hole location beyond the unit boundary setback. The bottom of the completed interval will be within the unit boundary setback at 600' FNL and 2219' FEL of Section 2. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.

Nearest wellbore permitted or completed in the same formation is the Castor 7-59 11-2-7 (Bison Oil & Gas II, LLC), as measured using 3D manual calculations.

The nearest wellbore belonging to another Operator is the Fiscus #1 (API: 123-14252), operated by Energy Minerals, as measured using 3D manual calculations. The well is DA.
