Noble is requesting to sundry the access road from the south to the north of this permitted location in an effort to minimize safety hazards during subsequent operations, mitigate any potential interference for large industrial equipment and avoid crossing the densely encumbered pipeline corridor south of the permitted locations.  
All existing wells affected by road route are currently being plugged and abandoned.  
Revised location drawing is also attached to document the reduction in disturbed area from 11.3 acres to 10.6 acres. Pad configuration has also changed.
