Comment: Location does not meet Final Reclamation requirements. Site, including the well pad & access road, are not re-contoured, de-compacted, or revegetated. All areas Not Needed for servicing the remote tank battery should be reclaimed. Reclamation work was to be completed within 12 months on non-crop land after Plugging of Well, which would have been 5/20/16. Tank Battery area and remaining access road will need to be reclaimed upon Plugging & Abandonment of API#103-10261.

Corrective Action:	Perform Final Reclamation per COGCC 1004 Rules including re-contouring, seeding of site and reclamation of all areas not needed for servicing of tank battery. Install appropriate BMPs to stabilize location until vegetation establishes; all Reclamation Activities to be complete by May 1, 2019.	Date	05/01/2019
