Comment: Access Road has not been reclaimed; road runs through Location to meet with Powerline track that appears to connect Surface owner fields that lie South of the County Road. Several other short roads East & West of Location appear to allow this same access. Vegetation is a mix of weedy and desirable species though no Noxious weeds were seen. Follow Up Insp in growing season will be needed to determine status of Vegetation. Operator is encouraged to perform vegetation assessment. Refer to Photo Log attached.

Corrective Action:	Perform Final Reclamation per COGCC 1004 Rules; reclaiming access road; and performing any Reclamation activities determined necessary to ensure uniform establishment of vegetation across all disturbance areas.
