Comment: Areas of the well location appear to be sufficiently vegetated and meets 1000 reclamation requirements. Three above ground steel tanks remains at the tank battery location southwest of well (0.10 miles). Battery equipment needs to be removed and location reclaimed in accordance with COGCC 1004.a reclamation rules.

Corrective Action:

Date **03/31/2019**

Remove tanks and perform reclamation in accordance with COGCC 1000 series rules and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels on the tank battery facility. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be completed no later than 3/31/2019.
