	<p>This location does not meet reclamation requirements; concrete pump base remains on location. Three above ground steel tanks from battery (1/4 mile NE of well) have not been removed. Location remains predominantly undesirable weedy plant species or bare and exposed soil. Records show well PA 3/18/2013. COGCC rule 1004.a requires all debris and surface equipment shall be removed within three (3) months of plugging a well, and that all reclamation work shall be completed within twelve (12) months on non-crop land after plugging a well. Concrete base and tanks should have been removed by 6/18/2013, all reclamation activities should have been completed by 3/18/2014</p>	
Corrective Action:	<p>Perform reclamation in accordance with COGCC 1000 series rules including, but not limited to, removal of concrete pump base, tanks and any remaining surface equipment and debris, and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be completed no later than 3/1/2019.</p>	Date <b>03/01/2019</b>
