Comment This location is not in compliance with Rule 1003. Interim Reclamation rules require reclamation activities to be conducted within six months of last production date (4/30/2018) on non-cropland which should have been 4/30/18. Appears the Operator has started interim reclamation activities to reduce disturbance areas only needed for production operations at the location. However, doesn't appear the Operator has seeded the disturbance area in the first favorable season following rig demobilization. Refer to the attached inspection photos for more detail.

Corrective Action Perform reclamation in accordance to Rule 1003. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until the location meets Rule 1003 standards. Operator is directed to perform corrective actions outlined on this inspection report immediately. Doing so may decrease the duration of the alleged violations and the penalties that may be assessed pursuant to Rule 523.
