This sundry is following up on Inspection number 690900023. During Annual Report preparation it was determined that follow-up was by email and phone, not in a Form 4. The formal follow-up is this Form 4.

The work on the 32C location was completed upon receipt of the inspection notice. The following work was undertaken:

- \*Clean-up of location, including removal of trash and debris, location condition observed during site visits
- \*The hoses that remain in the pit are part of the inlet and outlet hoses, unused hoses have been removed
- \*Gates are closed and secured, operators observed condition of additional locks on location
- \*New signs were installed including Caerus contact information
- \*Repairs to southern end of the net were made and operators monitor net conditions; additional repairs will be scheduled, as needed, weather permitting
- \*The pit has a maximum level of 15 feet to account for freeboard, the pit is not filled above that mark
