Noble Energy respectfully requests continued TA status. The well is closed to the atmosphere via a CIBP bridge plug set at 6835' on 2/8/2018. The well is closed to the atmosphere and locked out and tagged out at the master valve. The well was completed in the Niobrara-Codell formation. This well was TA'd for an MIT. Noble will return the well to production once a rig is available - unknown time frame as we are currently working through a large back log of P&A work for offset mitigation work for DJ basin activity. Form 5A to change the status to TA was submitted on doc # 401899750. Initial pressure test is attached. Successful MIT was performed on 2/21/2018 and was submitted on doc # 401576775.
