**COMMENTS:**

TEP Rocky Mountain LLC (TEP) requests permission to tie the bradenhead into the separator downstream of the choke on the PA 21-25 well. A diagram for plumbing the bradenhead into the separator is attached. This well was completed April 26, 2018 and bradenhead pressure reached 312 psi on 1/10/2019 after a seven (7) day buildup. The bradenhead has been flat at this pressure since then, as of 1/22/2019 the pressure is 306 psi.

Safety:  
This will allow the bradenhead pressure to equalize with our separator/line pressure which is currently 125 psi (1/29/2019) and protect the integrity of the surface shoe by preventing a pressure increase. There will be a check valve (720# class) in the line to negate backpressure from the separator in the bradenhead if separator pressure was to increase above bradenhead psi.
