COMMENTS:

TEP Rocky Mountain LLC (TEP) requests permission to tie the bradenhead into the separator downstream of the choke on the PA 524-24 well. A diagram for plumbing the bradenhead into the separator is attached. This well was completed April 25, 2018 and bradenhead pressure reached 481 psi on 10/22/2018 after a seven (7) day buildup. The bradenhead has been flat at this pressure since then, as of 1/25/2019 the pressure is 502 psi.

Safety:

This will allow the bradenhead pressure to equalize with our separator/line pressure which is currently 125 psi (1/29/19) and protect the integrity of the surface shoe by preventing a pressure increase. There will be a check valve (720# class) in the line to negate backpressure from the separator in the bradenhead if separator pressure was to increase above bradenhead psi.
