#### COMMENTS:

TEP Rocky Mountain LLC respectfully requests to vent the bradenhead for 1 year. TEP's calculations for pressure at the surface shoe set depth have determined that the GV 82-5 well's shut in pressure, combined with the hydrostatic pressure of the fluid and gas column in the production casing annulus, have exceeded a 0.683 psi/ft gradient at the shoe. In order to alleviate this pressure, TEP requests permission to vent the bradenhead if the calculated pressures exceed the 0.683 psi/ft gradient in order to avoid potentially breaking down the surface shoe.
